### 2. Composition/information on ingredients

Within the present knowledge of the supplier, this product does not contain any hazardous ingredients in quantities requiring reporting in this section, in accordance with EU regulations or National regulations.

### 3. Hazards identification

The preparation is not classified as dangerous according to Directive 1999/45/EC and its amendments.

### 4. First aid measures

#### First-Aid measures

- General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.
- Inhalation** : Remove to fresh air. Keep person warm and at rest. If not breathing, if irregular breathing, or respiratory arrest occurs provide artificial respiration or oxygen by trained personnel. Give nothing by mouth. If unconscious, place in recovery position and seek medical advice.
- Skin Contact** : Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use recognized skin cleanser. Do NOT use solvents or thinners.

<b>Handling</b>	: Keep container tightly closed.  Avoid contact with skin and eyes. Avoid inhalation of vapors and spray mist.  Eating, drinking and smoking should be prohibited in area where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.  Put on appropriate personal protective equipment (see Section 8).  Never use pressure to empty: container is not a pressure vessel. Always keep in containers made from the same material as the original one.  Comply with the health and safety at work laws.
<b>Storage</b>	: Store in accordance with local regulations. Store in a cool, well-ventilated area away from incompatible materials and ignition sources.  Keep away from: OXIDIZING AGENTS, strong alkalis, strong acids. No smoking. Prevent unauthorized access. Containers that are opened must be carefully resealed and kept upright to prevent leakage. Do not empty into drains..
